## **Overhead lines**

There has been some response, but not a lot, to my item last month – all of it however, the month - all of it, however, strongly in favour of burying the overhead lines and none of it against the idea. So I shall continue with my efforts and shall recommend to the Parish Council that we try to contact every cottage owner likely to be affected before going any further. Many of these we know but there are a lot of properties for whom we have no name or home address.

Someone has come up with the good idea of a map of the old village showing all the cottages. This I have now done with all the cottages whose owners are known to us shaded, the cottages where the owners are unknown have been left unshaded with a number where possible. I am sorry if the map is a bit difficult to read at this size but I have done my best to try and make it clear.

There may be workmen, suppliers, etc. who can help, I shall be very pleased to hear from them. I am also going to get in touch with Brays Estate Agents to see whether they are able to help.

Apart from this, I should still like to know if there is anyone out there who would like to assist me or even just offer moral support - I don't relish tackling the work all on my own!

We are creeping forward slowly but a lot more co-operation from the village would be encouraging - most of the support so far has come from the property owners not from residents of the village.



 ${\cal R}$  obin Penna has agreed to act as co-ordinator for the possible under ground cabling project whereby all the overhead electricity and elephone cables in the old part of the village are to be placed underground.


Anticipated costs for such a scheme are likely to be in the region of £90,000. It is expected that work could begin in two to three years time and take about three months to complete, the ideal time being from January to April. In the meantime funding has to be found and possible organisations to be approached include The County Environment Trust, English Heritage, South West Water, The Regional Development Agency and The Civic Trust.

In addition, it must also be remembered that some 112 properties in the old part of the village are second homes and it was suggested that they could be approached and the suggestion made that they make a contribution for a couple of years of the difference between the 'half' Council Tax rate they currently pay and the full rate. This would provide an average £300 per property per year.

It was also pointed out that the project would be deemed 'too small' to attract grant aid. It therefore might make more sense to consider an 'Amenity Scheme' for the whole village. This would require a lot more money and take longer to achieve but might attract money from the sources

Clearly, it is not going to be an easy task but to get things moving it was agreed that Robin Penna form a group of interested residents with Barry Goodright acting as link to the Parish Council.



These are the plans to underaround the power cables in the Conservation area of Port Isaac.

The existing uninsulated power cables, which carry a lethal voltage in excess of 415 Volts of alternating current, do not comply with the latest Directives and are in many cases below the legal height. STEER is concerned that when these cables are renewed they will be replaced with insulated cables. This would mean that each of the four cores of the cable has its own insulation so the single cable would be at

least ten times the size of the

Aver thirty people attended the initial open meeting on January 24th of the proposed parish regeneration group - and what a positive meeting it was. The main purpose was to form a working party and about 11 people indicated that they would be willing to be part of this group. This does not exclude anyone else who wants to be involved and every meeting of the group will be open to the public and widely reported.

If these insulated cables are erected to comply with new regulations they would be here forever.

Now is the time to underground all the wires and cables. Western Power Distribution has offered to pay £59,000 towards the cost of undergrounding. We are in the process of trying to raise the rest of the funds by talking to NCDC and BT etc.



# We might get rid of the cables!

News from STEER (StEndellion Economic Regeneration)

A breakthrough at last on cable undergrounding, thanks to the help of our MP Dan Rogerson. The undergrounding project received community support in the 2003 Parish Plan when 83% of those who completed questionnaires wanted to bury the overhead cables. Subsequent to the Parish Plan, we had contacted Western Power Distribution, and met Adam Walker, Planning Officer, who, from the start, has been very supportive in preparing plans, costings and generally advising us how to proceed. Western Power offered to cover the costs of supplying and laying the cables, including connecting to all properties, within the conservation area. However, we would need to obtain grant aid to fund the trenching costs.

A few months ago, Charlie David gave us the excellent news that NCDC had allocated £50,000 towards the project, providing a firm project was in place by the end of 2008. NCDC also arranged for one of their officers, James Ortiz, to work on our behalf. The remaining two parties still to get involved were the County Council, responsible for the street lighting, and British Telecom. James set to work on BT but as we had found, dealing with such a large organisation was very difficult, with no one willing to make any commitments.

However, at a recent meeting of the Climate Friendly Parish Group we met Dan Rogerson. He had been very supportive of our project by writing to BT on our behalf. When told of our struggle, he offered to arrange a meeting with the most senior BT man in our region, Bob Challacombe South Western Regional Director of BT Openreach . On 30<sup>th</sup> November, this meeting took place with Dan Rogerson, Bob Challacombe, Pat Garland - Area Manager for BT Openreach, James Ortiz -NCDC and representatives of STEER. Bob Challacombe agreed that BT would join the team and, although he could give no guarantee that all telephone cables would be undergrounded, agreed there was considerable scope for reducing the visual impact of BT infrastructure. He would be advising his local staff to liaise with Western Power on how this could best be achieved.

James Ortiz had in the meantime been working with the County Council, and arranged a meeting with their engineer, Peter Sainsbury. He will be visiting the

A n extremely well attended Tpublic meeting, held on February 20th, with over 50 people present, listened to Ms Check McEwen from Regeneration North Cornwall.

Check gave a very informative talk on Objective One and other sources of funding for the regeneration of North Cornwall. With her small team she works with all projects irrespective of where the funding comes from, guiding and advising along the way. She stressed that 'local support for what you want to do' is paramount and that the first step - a major piece of research, a survey of local needs and priorities, should be undertaken.

All Objective One funding is matched with a maximum of 50% available for suitable projects. This doesn't mean that the balance has to be raised locally; many other organisations are out there with money available for suitable projects.

European funding is time limited and ends in 2006. This may seem a long way ahead but all these things take time. So things now have to get moving and a further meeting is planned for Friday March 8th at 7.30pm in the Church Rooms (note the change of venue, the Village Hall will be getting ready for the Hospice Sale). The purpose of this

meeting is to elect a Working Group Chairperson and discuss the proposed constitution. If you want to join the group, please come along. If you can't make it please contact Robin Penna on 01208 880292.

## Going underground

 ${oldsymbol D}$  lans to bury underground electricity and telephone cables at the bottom  $\mathbf{r}$  of the village in the conservation area look likely to go ahead. As usual, one of the main stumbling grounds is money, with a total of £76,500 being needed. However, Adam Walker of Western Power Distribution pointed out that substantial grant aid had been obtained from a variety of sources for similar projects

In addition, the consent of every property owner affected would need to be obtained before work can start. Because of the narrow streets and lack of space, a lot of the trenching work and connections would need to be on private property, hence the consent requirements. Parish councillors agreed that they would help Western Power Distribution in establishing ownership. An added benefit of the availability of cable television could be an incentive to holiday homeowners to give their consent. Said Bryan Nicholls, 'Holiday home owners from up country tend to worry more about their income from lettings than the appearance of the village and may be reluctant to become involved, especially if there was any cost to them'. David Phelps pointed out that the aim of the project was to make the village more attractive and this in turn would make their properties more desirable.

County Councillor Helen Richards stressed that the initiative for any scheme must come from Port Isaac.


